- ❖ Floor space (as determined by the size of the booth)
- ❖ Needles punch carpet covering the booth area.
- ❖ 1 unit of 13 AMP single phase point.
- ❖ 1 unit of display table.
- ❖ 2 units of chair.
- ❖ 1 unit of wastepaper basket.
- ❖ Exhibitor's name on the fascia board.
- ❖ 1 unit of fluorescent light.

- ❖ Fascia signage has maximum 30 words. Request for additional words at RM1.00 per word must be submitted to the Organizer at least 14 days before event date.

TERMS & CONDITIONS

Terms and Conditions

1. TERMS OF REFERENCE

Under the rules and regulations of this contract, the term “Contract” means the contract for space at the “Event” entered into between the Organizer and the Exhibitor, which incorporates the rules and regulations and these terms of contract. The term “Event” shall mean the KN 2010 referred to on the application and contract form. The term “Exhibitor” shall include all employees and agents of any company, partnership, firm or individual to whom space has been allocated for the purposes of the Event. The term “Organizer” shall mean Borneo International Expo Sdn Bhd. The term “Venue” refers Bangunan Taman Kereta, Level 5, Off Jalan Padungan, 93100 Kuching, Sarawak, Malaysia unless otherwise determined by the Organizer.

2. APPLICATION FOR PARTICIPATION

All applications for participation shall be made on the prescribed application form and submitted to the Event Manager. The submission of the form shall deem to be confirmation of participation and acceptance by the Exhibitor of the Term of Contract. The Organizer reserves the right to accept or refuse any application without disclosing to the Exhibitor any reasons thereof.

3. TERMS OF PAYMENT

- a) A 50% is payable upon booking.
- b) Final payment is payable on or before 28th February 2010.
- c) Full payment is payable for all bookings made after 1st March 2010.
- d) Payment is payable to “**Borneo International Expo Sdn. Bhd.**” and crossed “Account Payee Only”.
(BANK ACCOUNT NO: OCBC BANK (M) BERHAD 760-109507-0).
- e) Cheques will be deposited when received for security reason but the application for participation will not be accepted until approved by Organizer.

4. ASSIGNMENT OF BOOTH

The Organizer reserves the right to assign the booth based on “first come first served” basis.

5. CANCELLATION AND DEFAULT IN PAYMENT

In the event of any cancellation or default in payment by the Exhibitor, the Organizer reserves the right and without liability to terminate the contract herewith and not refund any payment made. The Organizer will also have the right to re-let the booths contracted by the Exhibitor in default. In the event, the Organizer having elected to but not able to re-let the said space, the Exhibitor in default shall be liable to pay the entire unit cost to the Organizer as liquidated damages for the loss of rental.

6. BUILD-UP AND TEAR DOWN PERIOD

Exhibitors are to comply with the build-up and tear down schedules to be issued closer to the Event.

7. USE OF RENTED BOOTH / SPACE

Exhibitors are not allowed to build booths or place exhibits outside their booth area(including overhead area). No alteration or additional work to shell booths and their panel will be allowed without prior WRITTEN approval from the Organizer. No exhibit or material, which may cause danger or damages, will be allowed within the Exhibition halls. Exhibitors are not allowed to sub-let or assign the booths allotted to them to other parties either wholly or in part without the written consent of the Organizer.

8. DAMAGES

Exhibitors will be liable for any damages to the walls or to any part of the exhibition hall in which their exhibits are placed and shall not paint or stick anything onto the wall, alter the floor, ceiling, pillars or walls without the prior consent of the Organizer.

9. ELECTRICAL SUPPLY RULES & REGULATION

All Exhibitors are to comply with the electrical rules & regulations under existing Malaysian laws or according to generally accepted international standards. The Organizer reserves the right to stop all activities of the Exhibitors should it deem that electrical rules and regulations have been violated. All Exhibitors must refer to the Event Manager, i.e. IDA EXHIBITION SERVICES SDN BHD to obtain approval if changes need to be made to the standard electrical wiring laid by the Event Manager.

10. FIRE REGULATIONS

All materials used in the booths must comply with government regulations on fire safety. The Organizer reserves the right to stop any activity that is a potential fire hazard.

11. SPACE ONLY BOOTH

The Organizer appointed IDA Exhibition Services Sdn Bhd as the Official Shell Scheme Contractor. Exhibitors who have booked "Space Only" booths are encouraged to use the services of IDA Exhibition Services Sdn Bhd to undertake the job as this will facilitate convenient installation or another contractor of their choice. Contractors engaged by exhibitors are subject to the following rules and regulations. These rules also apply to contractors doing interior decoration to shell scheme booths. The Organizer reserves the right to reject any contractor and design, which they deem inappropriate.

12. OUTSIDE CONTRACTORS

Contractors, other than the officially appointed Contractor, carrying out Shell Scheme booth interiors, must lodge a Performance Bond with the Organizer before commencing work.

13. PERFORMANCE BOND

Before a contractor is permitted to start work, either he or his employing Exhibitor / group is required to place a refundable Performance Bond of RM50 per sqm with IDA Exhibition Services Sdn Bhd, and sign an undertaking to guarantee conduct, proper schedule of production and observance of the Exhibition and Hall regulations. All foreign employees and staff must be in possession of work permits issued by Ministry of Manpower and Immigration Department of the Government of Sarawak.

***PAYMENT MUST BE MADE IN CASH OR LOCAL CHEQUE.
BANKER'S GUARANTEE WILL NOT BE ACCEPTED.***

Only when the Performance Bond is placed and the undertaking signed, will the contractor / exhibitor be allowed to commence work.

Provided the booth is completed on time (by **18th March 2010**) and no damage is caused during the build-up, show days and tear-down, the Performance Bond will be returned to the Contractor / Exhibitor, in full, within 30 days of the completion of the Exhibition.

14. INSURANCE, LIABILITY & RISKS

The onus is on Exhibitors to take up appropriate insurance coverage against any claims arising from injury to persons or loss of property in their respective booths throughout the Event period. The Organizer and the Event Manager shall be duly indemnified by the Exhibitor against any injury or loss arising from the Exhibitor's participation in the Event.

15. SECURITY

The Organizer will provide guard service during the hours the Venue is closed. However, Exhibitors are solely and fully responsible for their own exhibit material and should insure their exhibit against loss or damage from any cause whatsoever. All property of an Exhibitor is understood to remain in its care, custody, and control in transit to or from or within the confine of the Event Hall. Exhibitors also agree to waive its right of subrogation against the Organizer, its officers, directors and employees.

16. CLEANING

The Organizer shall provide routine cleaning services in the general area throughout the Event period. Nevertheless, all Exhibitors are responsible for the removal of their construction and storage materials and the daily maintenance of their booths.

17. TERMINATION

The Organizer shall be entitled to terminate this Contract immediately by giving notice in writing to the exhibitor upon the happening of any of the following:

- a) The Exhibitor is distributing software, films, sound recordings, soundtracks and songs by way of sale, rental, lease or lending without prior written permission from the Organizer.
- b) The Exhibitor is in breach or fails to perform any obligation or provision under these Terms of Contract.

Upon receipt of notice of termination from the Organizer by the Exhibitor all rights granted to be Exhibitor by the Organizer made under the Contract shall cease and the Exhibitor shall immediately cease all participation in the Event and shall remove all materials, posters and other items belonging to the Exhibitor from the Exhibitor's booth(s). If the Exhibitor does not comply with this provision within one (1) hour of receipt of this notice the Organizer shall be entitled to evict the Exhibitor and remove all materials, posters and other items belonging to the Exhibitor from the Exhibitor's booth(s).

Upon termination of this contract, the Organizer shall be entitled to retain any and all payment (being payment for the Exhibitor's participation in the Event) made by the Exhibitor to the Organizer.

18. QUALIFIERS

❖ **Changes and Alterations**

The Organizer reserves the rights to change the venue, size, date and duration of the Event should circumstances warrant in which the agreement by the Exhibitor to participate shall remain in force without entitlement to any claims for compensation or replacement in connection with the changes.

❖ **Interpretation**

The Organizer reserves the right to make such charges, amendments and additions to these terms as and when considered necessary for the proper conduct of the Event. The interpretation of any terms and conditions rests entirely with the Organizer whose decision shall be binding.

❖ **Dispute and Arbitration**

Any dispute between Organizer and Exhibitor regarding the interpretation of this contract shall be referred to a mutually agreed independent arbitrator under Malaysia law.

❖ **Liability**

Under no circumstances will Organizer be liable for lost of profits or other incidental or consequential damages. The Organizer shall not be liable for failure to perform its obligations under this contract as result of strikes, riots acts of God, or any other cause beyond its control. The rights of Organizer under this contract shall not be deemed waived expect as specifically stated in writing and signed by an authorized officer of the Organizer.

❖ **Permit From Relevant Authority**

For the use of music and software in whatever form at the Event, the Exhibitor shall be responsible to obtain written permission for the use of the said literary work from the publisher or its representative.

This Event is not a cheap sale event. Should Exhibitors want to offer goods on cheap sale, they are solely responsible in obtaining approval from the relevant authority.

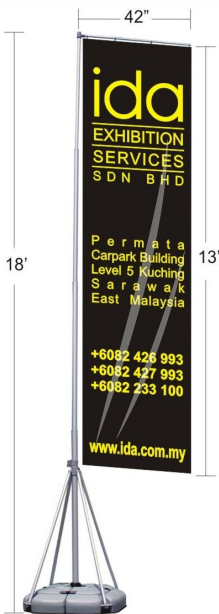
