

Terms and Conditions

1. These rules & regulations constitute an essential part of the contract for contestant participation. The Organiser reserves the rights to render all interpretations and to establish further regulations as may be deemed necessary for the general success of the Miss Star Sarawak Beauty Pageant, known hereafter as MSS.
2. The Organiser reserves the rights to decline, prohibit or expel contestants who, in the organiser's judgment, are out of keeping with the character of the beauty pageant. The reservation being all inclusive as to the person's characteristic, personality, function requirements, etc.
3. The control of all aspects of MSS shall rest upon the Organiser, whose decisions shall be binding on all contestants.
4. MSS is open to Malaysians only, or those born in Malaysia, or with at least 6 months continuous residency in Malaysia at the time of entry and hold a current Malaysian passport.
5. Only contestants between the age of 18 and 25 years of age on 19th March 2011 are permitted to contest for MSS.
6. Contestants must be single, never been married, nor have any children in the past.
7. No person who has taken part at any time in the Final of any competition or has qualified for the Final of any competition during the same period as MSS is eligible to enter the contest. Special permission may be given by the organisers in extenuating circumstances.
8. There must be nothing in the contestant's background that could bring into disrepute any aspects of the contest or its sponsors.
9. Entry forms must be filled in with names as they appear on the Malaysian Identity Cards, and not assumed any professional names.
10. Having signed the entry form and qualified for the final, contestants are reminded that they have signed a contract and as such breach of the contract is a serious matter.
11. Contestants are to arrange for their own accommodation, food, and travel to all auditions.
12. MSS Champion, 1st Runner-Up, and 2nd Runner-Up winners will be eligible to sign a One (1) Year Contract with the organiser.
13. By entering the selection process and ultimately the contest, a contestant grants the organisers and/or the sponsors of the beauty pageant the free and unfettered right to use her name, photographs, voice, likeness, recommendations, etc., relating to the contest, its title or any such connections between the contestant and the contest or title in any way it sees fit for advertising or sales promotion purposes, providing such usage is not in a manner to cause harm to the contestant's reputation or name. Such agreement will continue in a similar manner for further material issued resulting in participation in the contest or during year of office if she wins the title. No guarantee will be given on the return of any materials sent to the organisers as part of an application.
14. Contestants agree that from the date of winning a qualifying contest, until a period of Fourteen (14) days after the MSS Finale, or for a period of Six (6) months after their reign as titleholder ends, they will not, without the prior permission in writing from the organisers, make any statement to the media, either directly or indirectly, nor give any interviews nor write any stories whatsoever appertaining to the contest or involving its name.
15. It must be emphasised that the organisers cannot in any way be held responsible in any circumstances for the loss of any contestant's personal effects during the run of the contest. Contestants are to mane their own personal effects and/or belongings at all times. When appropriate, contestants are advised to purchase their own insurance policies on all relevant items, and deposit all valuables in hotel safety boxes.
16. In the event of any dispute over the rules of the contest, the decision of MSS organisers is final.
17. The Organiser shall have full power in the interpretation and enforcement of all rules and regulations contain herein and the power to make such amendments thereto and such further rules and regulations as it shall consider necessary for the proper conduct and success of the beauty pageant.
18. The interpretation, construction, performance and adjudication of all legal relationships between the Organiser and the Contestants shall be subject to laws of Malaysia. Any dispute shall be subject or respects to the law of Malaysia.
